1. Matt called the meeting to order at 9:03am.

2. Treasurer Report

- a. Arene reported there was an unexpected linked PayPal account to our PayPal account. Arene closed down the account and established new account numbers. Kerry mentioned that we no longer use PayPal anymore Finipay has money on hold and will start releasing money.
- b. Arene presented two profit and loss statements, and pointed out new line items under programs (GSTF, awards, maintenance workshop, etc.) Arene also mentioned that we canceled the maintenance workshop.
- c. Kerry asked if all GSTF invoices have been paid, Arene stated she has paid invoices for shirts.
- d. Arene reported that the net assets are just shy of \$21,000.
- e. Eric asked if there were members that did not renew. Arene pointed out that although professional memberships are down, Agency memberships are higher than budgeted.
- f. Eric made a motion to accept the treasurer report, John seconded, all approved.
- g. Eric made a motion to accept the minutes from July 19, 2022, seconded by Justin, all approved.

3. Executive Director Report

- a. Kerry updated all the membership fees and stated that the association is gaining some new members.
- b. Calendar of events reviewed- Kerry reminded the group of the Fall REC Connect newsletter deadline is coming up on Friday.
- c. We will be back at Funspot for the annual NHRPA holiday social in December.
- d. NNREPC moved to Mountain View Grand, we will hold a business meeting at conference.
- e. Kerry reminded everyone about deadlines for newsletters and the dates for coffee talks. March 2023 meeting at Cannon Mountain. April 13, 2023 NHRPA workshop & awards.
- f. Special Olympics met with Kerry and reported that their participation numbers are down 40%. Kerry mentioned that partnering with them would be a good opportunity to continue our inclusion initiatives. Other Rec Departments throughout the country have therapeutic professionals, NH does not, and this could be a good learning opportunity/partnership.

- c. Kerry said we're waiting on landscape structure grant to come in for the State Conference's keynote speaker.

Paul said meets went great, we are in a rebuilding phase, would like to have a presence at the State conference to talk with other agencies and gain feedback. The goal was to have the program operate on a regional level, however, Maine has pulled out and Vermont is going in their own direction. The current goal moving forward is to strengthen our current State program. Arene mentioned the State conference may be a good time to solicit sponsorships from vendors.
